## About the Polin Institute

As early as 1930, Julius and Inez Polin drew up a deed of gift concerning the above-mentioned parent fund. In a letter to the delegation of the Abo Akademi University Foundation in 1935, Julius Polin stated that a portion of the returns from this fund should go to the Julius Polins förfäders Minnesfond subsidiary fund. The latter fund was established in the memory of three of Julius Polin's ancestors, all of whom were priests educated at the Royal Academy of Turku. According to the deed of gift, the annual return or a suitable portion thereof "should be used to support Swedish theology students in Finland". The following year, in 1936, after consulting with Åbo Akademi University's then rector, Otto Andersson, Julius Polin made an addition regarding the Julius Polins förfäders Minnesfond fund. The addition read as follows: "Only once the return from the said fund becomes available, and the theological faculty's need for scholarship funding for Swedish theology students has been met by other means, is the faculty entitled to use the funds or part thereof for maintaining and developing the faculty's activities." This explicit purpose serves as a guiding principle for all of The Polin Institute's activities.

Traditionally, Western theology has neglected the perspective of the Eastern Oriental Churches, not only from a linguistic point of view (the exclusion of Syriac, Ge'ez, Arabic from the curriculum of theological studies), but also from a theological point of view. Church history and the history of dogmas focus almost exclusively on Western Christianity, with partial consideration of the Greek Orthodox tradition. An example of this can be the textbook *Teologins historia* (English: History of Theology, also translated into German, Portuguese and Russian) written by the renowned Swedish scholar Bengt Hägglund, which is still used today. Eastern Oriental Christianity, which historically includes both the Nicene/Chalcedonian churches and the non-Nicene/Chalcedonian churches, has unfortunately remained somewhat unclear and unknown.

This Pauline day will focus on pre-Nicene theology, the Nicene Creed, theological reception in late antiquity, will further discuss Christological topics, as well as modern ecumenical relations between the churches of the East and West.








### Jouko N. Martikainen



## Nicene Themes with un-Greek Instruments? Ephrem the Syrian

At the core of Nicene theology lies the concept of ὁμοούσιος, an abstract Greek term inherently philosophical and ontological in nature, rooted in the Greek traditions of viewing the world in the level of static, abstract ideas. How, then, might one reflect this theological vision within a language and culture where ontological concepts are virtually absent, and ideas are more commonly expressed in dynamic terms – as processes rather than states? Ephrem the Syrian (d. 373) was the leading voice of Nicene Christology in the Syriac East. How did he respond to this challenge?

Serafim Seppälä is a professor of systematic theology and patristics at the University of Eastern Finland since 2007. He studied comparative Semitic linguistics and Islamic studies at the University of Helsinki, where he earned his PhD in 2002. Following several years at the Monastery of New Valaam, he pursued an academic career but continues to serve as an archimandrite in the Orthodox Church of Finland. His research interests span a wide range of topics in early Eastern Christian literature, including Byzantine aesthetics, Syriac and Greek ascetic and mystical theology, the interaction between Judaism and Eastern Christianity in late antiquity, the encounter between early Islam and Christianity in the Middle East, and the cultural heritage of the Armenian genocide.

### Aphrahat and Nicaea: Review of Research

Aphrahat the Persian Wise (d. 345?) wrote Demonstrations only some twenty years after the council of Nicea. Aphrahat's idiosyncratic christology, exemplified in the 17th demonstration, has been in the middle of debate as the scholars have tried to relate Aphrahat to different christologies. As a contemporary writer, Aphrahat can also illuminate the (non)influence of Niceanum in geographically more distant parts of the early Church. This paper will present and review the discussion on Aphrahat, his christology, and their relation to Niceanum.




### Maros Nicak




### **Maros Nicak**
